Before the start of the meeting, the issue of postponement of meeting scheduled for 31.07.2015 to 07.08.2015 was raised by the elected members Mrs.Arita Sharma, Sh.Manish Gupta & Sh. Dinesh Gupta, Vice President. The PCB heard them and firmly stated that all action had been done properly and as per due procedure. He stated that the CEO had acted as per directions of competent Authority. He said that this was a non issue and any further discussion on the matter will be a waste of Board's time, which has convened to discuss issues related to development and welfare of Subathu Cantt. He advised the elected members to not challenge the valid Authority of PCB and to behave responsibly in the future. He also advised the elected members that recurrence of such scenes should be avoided in future.

Point No.09 : **VOCATIONAL TRAINING AND SKILL DEVELOPMENT.** The Board examined the committee report. The Committee had recommended that "A person should be appointed who has experience with Vocational Training Centers, their establishment, working, correspondence and their affiliation with SCVT, Sundernagar to ensure proper functioning of the VTC". A detailed discussion between Sh. Manish Gupta, one of the committee members, and the PCB followed. Finally the Board resolved that:-

i) All six elected members should recommend what courses should be run at the VTC and how many people will be interested in each of these courses by conducting a survey in their respective wards. This report should be submitted within one week. The feasibility and viability of courses should be kept in mind by the elected members while making the recommendations.

ii) The Board resolved that the committee constituted for the purpose of certification/ accreditation of courses at VTC should recommend the name of the person to be engaged, the honorarium to be paid and the basis of payment to such person, and this report be placed before the Board in the next ordinary Board meeting.
